Act 34 COMPLIANCE (Background Check of Prospective Employees)

Each Pennsylvania resident must submit with his/her employment application a copy of a report of <u>Criminal History Record Information</u> from the Pennsylvania State Police or a statement from the Pennsylvania State Police that the State Police Central Repository contains no such information relating to that person. The criminal record history report must be no more than one (1) year old. The applicant <u>MUST</u> submit the <u>ORIGINAL</u> report prior to employment.

Act 151 (Child Abuse History Clearance)

Each candidate must submit with his/her employment application a copy of an official clearance statement obtained from the Pennsylvania Department of Public Welfare or a statement from the Department of Public Welfare that no record exists. The clearance statement must be no more than one (1) year old. The applicant <u>MUST</u> submit the <u>ORIGINAL</u> report prior to employment.

Act 113 (FBI Federal Criminal History Record)

Each candidate must complete FBI fingerprints and submit their Registration ID with his/her employment application that will show a statement of no record when results are obtained. The clearance statement must be no more than one (1) year old.
